PUBLIC HEARING FOR LOCAL LAW #2 FOR 2015

PUBLIC HEARING ON 2016 TOWN BUDGET

6:00 and 6:30 p.m.

There were 2 Public Hearings for the Town of Leicester held on Tuesday, November 3, 2015. The first one was for Local Law #2 for the year 2015 – A local law authorizing the Town Board to override the limit on the amount of real property taxes that may be levied by the Town of Leicester for the fiscal year 2016 as limited by General Municipal Law §3-C which will allow the Town Board to adopt a budget for the fiscal year 2016.

The second public hearing was to adopt the 2016 Budget for the Town of Leicester.

Present Lisa Semmel, Supervisor; Dave Fanaro, Joni Santucci, Karen Roffe and Matt Durbin, Councilpeople and Mary Yasso, Clerk.

The meeting was called to order and the Pledge to the Flag was led by Matt Durbin.

The Supervisor opened the Public Hearing on Local Law #2 and declared the hearing open for ½ hour for all interested people to ask questions and make statements.

The Supervisor noted that she had received an invitation to the York Central School Assembly for Veteran's Day. It is on November 9, 2015 at 9:45 at the school.

The Livingston County Inmates cleaned up leaves in the cemetery.

David Terry the Town of Leicester representative to the Livingston County Youth Bureau needs to resign. The Board will appoint a new representative at the next regular meeting.

The Supervisor attended a County Ambulance Meeting. Other towns are also using the county ambulance service and are not under the agreement. So at this time we are not paying for it.

It was decided to have a new telephone system installed in the Town Hall.

6:30 p.m. The Supervisor again asked if there were any questions or statements regarding Local Law #2 for the Town of Leicester. There were none.

Close Public Hearing A motion was made by Matt Durbin and seconded by Dave Fanaro to close the Public Hearing. Motion Carried, Ayes 5, Noes 0.

Adopt Local Law #2 A motion was made by Karen Roffe and seconded by Matt Durbin to adopt Local Law #2 for the Town of Leicester. Motion Carried, Ayes 5, Noes 0.

The Supervisor declared the Public Hearing for the 2016 Town Budget open for ½ hour. She asked if there were any questions or comments, there were none.

7:00 p.m. Close Public Hearing A motion was made by Joni Santucci and seconded by Matt Durbin to close the Public Hearing. Motion Carried, Ayes 5, Noes 0.

Adopt 2016 Budget A motion was made by Matt Durbin and seconded by Joni Santucci to adopt the Preliminary Budget as the Budget for 2016.

Whereas the Town Board has met at the time and place specified in the notice of Public Hearing on the Preliminary Budget and heard all persons desiring to be heard thereon, now be it further Resolved that this Town Board does hereby adopt such Preliminary Budget as filed as the Annual Budget for this Town for the fiscal year beginning the first day of January 2016, and that such budget so adopted as entered in detail in the minutes of the proceedings of the Town Board, November 3, 2015 and be it Further Resolved, the Town Clerk of this Town shall prepare and certify in duplicate copies of said Annual Budget as adopted by this Town Board together with the estimates, if any, adopted pursuant to Section 202-A Subd. 2 of Town Law and Board of Supervisors.
