PUBLIC HEARING ON 2017 BUDGET

The Work Meeting and the Public Hearing on the 2017 Budget were held on Tuesday, November 8, 2016 at 6:00 at the Leicester Town Hall.

The Meeting was called to order and the Public Hearing was opened. The Clerk read the Notice of Public Hearing. The Supervisor asked if there were any comments or questions regarding the budget and there were none. The Hearing was declared open for ½ hour.

There was discussion with the Highway Superintendent on what the Highway Department was currently working on.

It was decided to hire Municipal Consulting Services and Grant Writing to complete the paperwork regarding the salt storage building with the DEC.

The Supervisor asked again if there were any comments or questions regarding the budget and there were none.

A motion was made by Matt Durbin and seconded by Jerry Hull to close the Public Hearing. Motion Carried Ayes 4, Noes 0.

Adopt 2016 Budget A motion was made by Joni Santucci and seconded by Matt Durbin to adopt the Preliminary Budget as the Budget for 2017.

Whereas the Town Board has met at the time and place specified in the notice of Public Hearing on the Preliminary Budget and heard all persons desiring to be heard thereon, now be it further Resolved that this Town Board does hereby adopt such Preliminary Budget as filed as the Annual Budget for this Town for the fiscal year beginning the first day of January 2017, and that such budget so adopted as entered in detail in the minutes of the proceedings of the Town Board, November 8, 2016 and be it Further Resolved, the Town Clerk of this Town shall prepare and certify in duplicate copies of said Annual Budget as adopted by this Town Board together with the estimates, if any, adopted pursuant to Section 202-A Subd. 2 of Town Law and Board of Supervisors.

Town Supervisor - \$9,000

Justice of the Peace (2) - \$5,780 each

Councilperson (1) - \$3,295

Councilpersons (3) - \$3,135 each

Highway Superintendent - \$55,210
