LOCAL LAW NO. 2 OF THE YEAR 2019

OF THE TOWN OF LEICESTER

A local law to amend the boundaries of a certain zoning district currently known as the Industrial Use District within the Town of Leicester, Livingston County, New York, changing such certain specified area to Agricultural Use District.

Be it enacted by the Town Board of the Town of Leicester as follows:

SECTION 1. TITLE AND SCOPE

This local law shall be known as “A LOCAL LAW TO AMEND THE BOUNDARIES OF A CERTAIN PORTION OF THE INDUSTRIAL USE DISTRICT AND TO CHANGE A PORTION OF SUCH AREA BY EXTENDING THE BOUNDARIES OF THE AGRICULTURAL USE DISTRICT OF THE TOWN OF LEICESTER, LIVINGSTON COUNTY, NEW YORK.”

SECTION 2. PURPOSE.

The purpose of this local law is to modify the boundaries of a portion of the Industrial Use District within the Town, changing such certain specified area to a new classification of Agricultural Use District.

SECTION 3. LOCATION OF MODIFIED ZONING DESIGNATION.

The parcel to be amended from Industrial Use District to a new designation of Agricultural Use District is located on the south side of New York State Route 20A (also known as Cuylerville Road), west of where it intersects with Barrett Road and being further described as follows:

All that tract or parcel of land situate in the Town of Leicester, County of Livingston, State of New York, known as ____ Cuylerville Road and bearing Tax Identifier Map Parcel Number: 88.-3-47.121.

Containing 24.77 Acres, more or less.

A portion of the subject parcel already bears a zoning classification of Agricultural Use District. The intent of this local law is to change the remaining portion of the parcel that is still classified as Industrial Use District so that the entirety of the parcel is classified as Agricultural Use District.

Hereafter, the totality of those encompassed by Tax Identifier Map Parcel Number 88.-3-47.121 shall be classified as part of the Agricultural Use District and the official Zoning Map of the Town of Leicester shall be amended to reflect such reclassification (although not contemporaneously with the adoption of this Local Law).

SECTION 4. EFFECTIVE DATE.

This local law shall be effective immediately upon its filing with the Office of the Secretary of State.
